Vendor shall be responsible and liable for the payment of any and all of the foregoing attorney’s fees and costs, to attorneys of Long Beach’s selection, for any investigation and review, pre-litigation, litigation, post-judgment litigation, and any and all appeals arising out of and/or relating to this Agreement.
