BOND ORDINANCE AUTHORIZING THE RECONSTRUCTION AND/OR RESURFACING OF VARIOUS ROADWAYS IN THE TOWNSHIP OF LONG BEACH, COUNTY OF OCEAN, NEW JERSEY; APPROPRIATING THE SUM OF \$450,000 THEREFOR; AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS OR BOND ANTICIPATION NOTES OF THE TOWNSHIP OF LONG BEACH, COUNTY OF OCEAN, NEW JERSEY IN THE AGGREGATE PRINCIPAL AMOUNT OF UP TO \$427,500; MAKING CERTAIN DETERMINATIONS AND COVENANTS; AND AUTHORIZING CERTAIN RELATED ACTIONS IN CONNECTION WITH THE FOREGOING

BE IT ORDAINED by the Board of Commissioners of the Township of Long Beach, County of Ocean, New Jersey (not less than two-thirds of all the members thereof affirmatively concurring), pursuant to the provisions of the Local Bond Law, constituting Chapter 169 of the Laws of 1960 of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

<u>Section 1</u>. The purpose described in Section 7 hereof is hereby authorized as a general improvement to be made or acquired by the Township of Long Beach, County of Ocean, New Jersey ("Township").

Section 2. It is hereby found, determined and declared as follows:

- (a) the estimated amount to be raised by the Township from all sources for the purpose stated in Section 7 hereof is \$450,000; and
- (b) the estimated amount of bonds or bond anticipation notes to be issued for the purpose stated in Section 7 hereof is \$427,500; and
- (c) a down payment in the amount of \$22,500 for the purpose stated in Section 7 hereof is currently available in accordance with the requirements of Section 11 of the Local Bond Law, N.J.S.A. 40A:2-11.

Section 3. The sum of \$427,500, to be raised by the issuance of bonds or bond anticipation notes, together with the sum of \$22,500, which amount represents the required down payment, are hereby appropriated for the purpose stated in this bond ordinance ("Bond Ordinance").

The issuance of negotiable bonds of the Township in an amount not to Section 4. exceed \$427,500 to finance the costs of the purpose described in Section 7 hereof is hereby authorized. Said bonds shall be sold in accordance with the requirements of the Local Bond

In order to temporarily finance the purpose described in Section 7 hereof, the issuance of bond anticipation notes of the Township in an amount not to exceed \$427,500 is hereby authorized. Pursuant to the Local Bond Law, the Chief Financial Officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver the same to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their date to delivery thereof. The Chief Financial Officer is hereby directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this Bond Ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

The amount of the proceeds of the obligations authorized by this Bond Section 6. Ordinance which may be used for the payment of interest on such obligations, accounting, engineering, legal fees and other items as provided in Section 20 of the Local Bond Law, N.J.S.A. 40A:2-20, shall not exceed the sum of \$90,000.

The improvement hereby authorized and the purpose for which said Section 7. obligations are to be issued; the estimated costs of said purpose; the amount of down payment for said purpose; the maximum amount obligations to be issued for said purpose and the period of usefulness of said purpose within the limitations of the Local Bond Law are as follows:

The supplemental debt statement provided for in Section 10 of the Local Bond Law, N.J.S.A. 40A:2-10, was duly filed in the office of the Clerk prior to the passage of this Bond Ordinance on first reading and a complete executed duplicate original thereof has been filed in the Office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. The supplemental debt statement shows that the gross debt of the Township, as defined in Section 43 of the Local Bond Law, N.J.S.A. 40A:2-43, is increased by this Bond Ordinance by \$427,500 and that the obligations authorized by this Bond Ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 9. Grants or other monies received from any governmental entity, if any, will be applied to the payment of or repayment of obligations issued to finance the costs of the improvement described in Section 7 above.

The full faith and credit of the Township are irrevocably pledged to the Section 10. punctual payment of the principal of and interest on the bonds or bond anticipation notes authorized by this Bond Ordinance, and to the extent payment is not otherwise provided, the Township shall levy ad valorem taxes on all taxable real property without limitation as to rate or amount for the payment thereof.

The Capital Budget is hereby amended to conform with the provisions Section 11. of this $\overline{\text{Bond Ordinance}}$ to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended Capital Budget and Capital Program as approved by the Director of the Division of Local Government Services, is on file with the Clerk and available for inspection.

The Township hereby declares its intent to reimburse itself from the Section 12. proceeds of the bonds or bond anticipation notes authorized by this Bond Ordinance pursuant to Income Tax Regulation Section 1.150-2(e), promulgated under the Internal Revenue Code of 1986, as amended ("Code"), for "original expenditures", as defined in Income Tax Regulation Section 1.150-2(c)(2), made by the Township prior to the issuance of such bonds or bond anticipation notes.

The Township hereby covenants as follows: Section 13.

it shall take all actions necessary to ensure that the interest paid on the (a) bonds or bond anticipation notes authorized by this Bond Ordinance is exempt from the gross income of the owners thereof for federal income taxation purposes, and will not become a specific item of tax preference pursuant to Section 57(a)(5) of the Code;

- it will not make any use of the proceeds of the bonds or bond (b) anticipation notes or do or suffer any other action that would cause the bonds or bond anticipation notes to be "arbitrage bonds" as such term is defined in Section 148(a) of the Code and the Regulations promulgated thereunder;
- it shall calculate or cause to be calculated and pay, when due, the (C) rebatable arbitrage with respect to the "gross proceeds" (as such term is used in Section 148(f) of the Code) of the bonds or bond anticipation notes;
- (d) it shall timely file with the Internal Revenue Service, such information report or reports as may be required by Sections 148(f) and 149(e) of the Code; and
- (e) it shall take no action that would cause the bonds or bond anticipation notes to be "federally guaranteed" within the meaning of Section 149(b) of the Code.

The improvement authorized hereby is not a current expense and is an Section 14. improvement that the Township may lawfully make. No part of the cost of the improvement authorized hereby has been or shall be specially assessed on any property specially benefited thereby.

All ordinances, or parts of ordinances, inconsistent herewith are hereby Section 15. repealed to the extent of such inconsistency.

In accordance with the Local Bond Law, this Bond Ordinance shall take Section 16. effect twenty (20) days after the first publication thereof after final passage.

STATEMENT OF PURPOSE

This Ordinance amends Chapter 51 to amend the dune area and construction regulations.

SECTION I

 $\$51\mbox{-}3$ is hereby amended to repeal and replaced the first sentence with the following:

"The definitions set forth in Chapter 205, as well as the following definitions shall apply to this Chapter:"

SECTION II

§51-4 is hereby amended to repeal and replace B(1) as follows.

(1) All construction of buildings, structures, and decks, as well as any proposed expansion of the footprint of the foregoing, to the oceanfront building line shall be required to either obtain a Coastal Area Facility Review Act ("CAFRA") permit which approves the construction or obtain a jurisdictional determination from the state that a CAFRA permit is not required. All documentation submitted to the State to obtain either of the foregoing shall

include surveys and plans depicting all proposed buildings, structures, and decks included in all proposed construction and expansion.

SECTION III

All ordinances, or parts of ordinances, inconsistent with this ordinance are hereby repealed to the extent of such inconsistency

If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect

COMMISSIONERS' REPORTS

Commissioner Lattanzi thanked CFO Lydia D'Amore and Auditor Brian Logan for a good job with the budget. There was an increase of 4/10 of a penny which represented an increase in the total budget of approximately \$316,000.00 over the 2018 budget, and individual tax bills would see an increase of around \$37 per home, for the year. The increase was due to health care and pension contribution increases.

Commissioner Bayard advised P&A Construction started the water main project along the Blvd. which should be completed before summer.

Mayor Mancini announced the next meeting of the Land Use Board would be held on Wednesday, April 10th, 2019 at 7:00 pm in the upstairs multi-purpose room.

Second Reading and Public Hearing for Ordinances 19-10, 11C and 12 would take place at the public meeting held on May 6, 2019 at 4:00 pm. He noted the State accepted the Township tax maps and would begin the reassessment in the near future. Fire inspections were done through Ocean County. Information was available on the website and was also mailed with utility bills. Terminal Groin in Holgate Phase I was complete and beach erosion had improved. Once Phase II was complete, conditions were expected to improve again.

OPEN PUBLIC SESSION

Sue DeHaven/Brant Beach posed various questions regarding the fishing pier and proposed parking lot in Bayview Park; she asked if Long Beach Twp. would be moving forward with the project, where the idea came from and who requested it, and approximately how many vehicles were anticipated to access the handicapped parking area.

Mayor Mancini explained the proposed parking was for handicapped people who wanted to access the pier; he had received approximately 18 requests for accommodation. The plans had been modified from 7 down to 5 spaces; the DEP would notify affected property owners regarding the public comment period.

Sue DeHaven/Brant Beach stated she had never seen anyone fishing from the pier and felt there currently was adequate parking. She added there was no ADA requirement, and parking spots were not permitted in wetland areas.

Mayor Mancini advised proposed parking was not located in a wetlands-designated

Dennis O'Day/Brant Beach asked if there was a mandate for handicapped parking and stated the area was designated as wetlands.

Mayor Mancini stated there was no mandate for handicapped parking, however the Board of Commissioners were committed to making the fishing pier accessible for public use and enjoyment. He reiterated the fact that the area was not wetlands.
