ORDINANCE 18-22C

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED, "CODE OF THE TOWNSHIP OF LONG BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY, (1997)" IN CHAPTER 114 PERTAINING TO THE REGULATIONS OF PLASTIC BAGS

THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF LONG BEACH DOES ORDAIN:

STATEMENT OF PURPOSE

This Ordinance amends and further clarifies the definitions relating to the regulation of plastic bags.

<u>SECTION I</u>

§114-1 is hereby amended to add the following definitions.

PLASTIC

Any of numerous organic, synthetic, or processed materials that are mostly thermoplastic or thermosetting polymers of high molecular weight and that can be made into objects, films, or filaments. The definition of plastic shall also include plastic made from polylactic acid or polylactide, as well as other biodegradable plastic derived from renewable resources, such as corn starch, cassava roots, chips or starch, or sugarcane and that decomposes naturally in the environment.

POLYETHYLENE

A tough, light, flexible, and/or synthetic resin made by polymerizing ethylene, chiefly used for plastic bags, food containers, and other packaging. It is a polymer of ethylene; especially any of various partially crystalline lightweight thermoplastics (CH2CH2)x that are resistant to chemicals and moisture, have good insulating properties, and are used especially in packaging and insulation.

SECTION II

§114-1 is hereby amended to delete the word "diary" in the definition of GOODS AND PRODUCTS and replace with the word "dairy."

SECTION III

All Ordinances or part of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION IV

If any word, phrase, clause, section or provision of this Ordinance shall be found by any court of competent jurisdiction to be unenforceable, illegal or unconstitutional, such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION V

This Ordinance shall take effect upon publication thereof after final passage according to law.

Commissioner Lattanzi announced the next meeting of the Land Use Board would be held on Wednesday, August 8th at 7:00 pm in the upstairs multi-purpose room.

The September 10th Meeting had been cancelled; both Public and Executive Sessions had been rescheduled for August 29th. Second Reading and Public Hearing for Ordinance(s) 18-23C, 18-24 and 18-25C would take place at the public meeting held on August 29, 2018 at 4:00 pm. Tax bills would be delayed due to late tax rate information from Ocean County. The Coquina Jam surf competition was a great event. He provided Transportation System facts and figures and noted the amount of Gator riders had almost doubled over last year's usage.

Commissioner Bayard had no comments.

OPEN PUBLIC SESSION

Angela Anderson, Long Beach Twp. provided information on the Marine Field Station on Osborn Ave., the programs there had been well attended, and she encouraged people to come visit. Oyster shell recycling program had been going great; they have collected 21 tons of shells, which equals 800 bushels, to regenerate the oyster population.

Janet Drew, Beach Haven Gardens would like the Twp. to recycle more diverse items, wanted balloons prohibited, and did not want a proposed pipeline to go through the pinelands.

Angela Anderson explained why only certain items are permitted to be recycled which was decided by Ocean County.

Maria Jonstonti asked for parking waivers for special events; the Coquina Jam specifically.

Donn O'Brien/Brant Beach advised construction noise disturbs summer renters and would like construction hours reduced.

Commissioner Lattanzi explained the permissible hours, days and sound level could be found in the Township Code Book in the Noise Chapter, 123. Many weather-specific projects must take place in the summer and provide many jobs.

Doris Martin, Brant Beach questioned meeting minutes, posting them online and would like to be able to digitally read everything the Twp. was doing.

Bill Hutson, Holgate questioned the new proposed Jetty in Holgate, Kyle Ominski responded with the current status of the project.

Judy Lubito, Jolly Rodger questioned why surveying was being done in Holgate.

Kyle Ominski, Administrator stated surveying was being done to determine the bulkhead line for dune location, to approximate the cost, as well as fact finding. He would be meeting with the State to finalize the project.

Commissioner Bayard advised the goal was to move the dune-line west, in order to expand the beach.

Bill Hutson/Holgate asked for information regarding an emergency permit for the Holgate beaches; Kyle Ominski responded it would streamline the permit process resulting in less time and regulation by the State.

Lorraine Morgan, Brant Beach asked if the beach entrances could be packed down with more dense materials; currently they were too soft to walk over.

Commissioner Bayard stated he would take care of the matter.

David Jones, Holgate questioned the status of a wetlands project in Holgate.

Commissioner Lattanzi advised sewer permits had not yet been received from the County and State. The area would not buildable until such approval was granted.
