Bidder shall be responsible and liable for the payment of any and all of the foregoing attorney's fees and costs, to attorneys of Long Beach's selection, for any investigation and review, pre-litigation, litigation, post-judgment litigation, and any and all appeals arising out of and/or relating to this Agreement.
2. The existence of any available and/or applicable insurance shall not waive or release Bidder from the Bidder's obligations set forth in this Agreement.
