1. Second Reading Ordinance 22-08: AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK IN 2022

Passed on first reading at a regular meeting held on March 7, 2022 and advertised in the BEACH HAVEN TIMES issue of March 10, 2022.

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Board of Commissioners finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Board of Commissioners hereby determines that a 1.0% increase in the budget for said year, amounting to \$242,245.02 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Board of Commissioners hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget, shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Board of Commissioners of the Township of Long Beach, in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2022 budget year, the final appropriations of the Township of Long Beach shall, in accordance with this ordinance and N.J.SA. 40A:4-45.14, be increased by 3.5%, amounting to \$847,857.57; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove, that is not appropriated as part of the final budget, shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services with 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

2. Second Reading Ordinance 22-09C: AN ORDINANCE AMENDING AN ORDINANCE ENTITLED, "CODE OF THE TOWNSHIP OF LONG BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY, (1997)" IN CHAPTER 39 WHICH PERTAINS TO ALCOHOLIC BEVERAGES

Passed on first reading at a regular meeting held on March 7, 2022 and advertised in the BEACH HAVEN TIMES issue of March 10, 2022.

STATEMENT OF PURPOSE

The purpose of the Ordinance is to authorize the Township to designate certain areas during Township-sponsored events at which people are permitted to carry and consumer open containers of alcoholic beverages outdoors.

SECTION I

§39-7 is hereby repealed and replaced as follows.

§39-7 Consumption in public.

- Except as set forth herein, no person shall at any time consume alcoholic beverages or have in his or her possession any open container containing any alcoholic beverage on any street, highway, alley, sidewalk, approach, or step to any building or in any automobile or other motor vehicle on any street, highway, or alley. No person shall at any time consume or have in his or her possession any open container containing any alcoholic beverage in any public building or public place except in a licensed establishment as regulated by the provisions of this Chapter and further licensed in accordance with State law. No person shall at any time consume or possess in any container opened or unopened any alcoholic beverage on any public beach.
- B. The prohibitions shall not prohibit an employee of a licensed premises or licensed building, licensed to sell alcoholic beverages, from carrying and having in his or her possession open containers of alcoholic beverages on a public sidewalk, approach, or step to any building if the same be necessary to serve patrons of the licensed establishment or building who are legally seated at outdoor seating as set forth in the Township Code, and nothing contained in this section shall prohibit customers or patrons of a lawfully licensed establishment or building from consuming alcoholic beverages while seated at any permitted outdoor seating, permitted pursuant to the terms of the Code.
- C. The prohibitions shall not prohibit any patron who is legally seated at outdoor seating as provided in the Township Code from consuming alcoholic beverages at such legal seating, which beverages are brought by the patron or a fellow patron sitting at the same table for personal consumption. It is the intent of this prohibition waiver to permit patrons of food establishments with lawful outdoor seating to bring their own bottle, often called "BYOB," to consume alcohol in advance of or with a meal to be consumed by persons legally seated at outdoor seating.
- The Township may by resolution designate specific public outdoor areas used for Township-D. sponsored events and for a set period of time to be an "open container area" where people of lawful drinking age are permitted to carry and consume open containers of alcoholic beverages outdoors.

SECTION II

All Ordinances or parts of Ordinance inconsistent herewith are repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION IV

This Ordinance shall take effect upon publication thereof after final passage according to law.

STATEMENT OF PURPOSE

The purpose of the Ordinance is to amend Chapter 5 to revise the special service charges for public records requests that require action by the Police Department.

SECTION I

§5-10C(1) is repealed and replaced with the following.

If the actual cost of duplication of government records exceeds the rates set by N.J.S.A. 47:1A-5, the actual cost of duplication shall be charged and whenever the nature, format, manner of collation, or volume of a government record embodied in the form to be located, inspected, reviewed and analyzed, redacted, and/or copied is

such that the record cannot be reproduced by ordinary document copying equipment in ordinary business size and/or where the location, inspection, review and analysis, and/or redaction involves an extraordinary expenditure of time and effort to accommodate the request, in addition to the actual cost of duplicating the record, if any, a special service charge shall be assessed and charged in accordance with the following.

- (a) Where the required work can be performed by an officer and/or employee of the Municipal Clerk's office, the special service charge shall be equal to the prorated salary of the lowest salaried employee in the Municipal Clerk's office for the time expended to comply with the request.
- (b) Where the required work must be performed by a member of the Police Department due to authorized access requirements and/or the nature of the records requested, the special service charge shall be equal to the prorated salary of the lowest ranked full-time police officer employed by the Police Department for the time expended to comply with the request.
- (c) Where the required work necessitates a third-party to perform the work, the special service charge shall be equal to the fees and costs charged by the third-party in accordance with the Local Public Contracts Law.

SECTION II

All Ordinances or parts of Ordinance inconsistent herewith are repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

WHEREAS, as set forth in the CRC's proposal, which is attached hereto as Exhibit A and incorporated herein, the services include: (i) the topographic/swimmer surveys to determine beach and nearshore profile variability and quantity volumetric changes, the CRC will complete profile surveys at 18 locations which will be surveyed twice in 2022 (March and September); (ii) Boat surveys the CRC will complete hydrographic surveys at 11 transect lines that were surveyed in 2019, 2020 and 2021 CRC field evaluations; (iii) Data Analysis, the CRC will process and reduce topographic/nearshore datasets and analyze using existing CRC software and data reduction

procedures using comparisons from 2019, 2020, 2021 and 2022; (iv) Report and Meetings, the CRC will submit a final report that summarizes the conditions and shoreline and volume changes.

WHEREAS, as a municipality located on an eighteen-mile-long barrier island, there are few issues, if any, more significant to the public health, welfare, and safety than the maintenance of the shoreline and the scientific study and reports relating to and in support of protection of the public from flooding; and

WHEREAS, based upon the services required and the expertise, reputation, its familiarity with the geographic location, and its proximity to the Township, the Township has concluded, based upon the advice of the Township's counsel and pursuant to the Certification of the Qualified Purchasing Agent ("QPA") that the services provided by CRC are specialized and qualitative in nature requiring expertise, extensive training and proven reputation in the field of endeavor, and, therefore, the contract complies with the EUS exception to the Local Public Contracts Law; and

WHEREAS, the designated administrative official of the Township duly prepared and filed a Certification with the Mayor and Commissioners describing in detail why the contract meets the legal requirements for an EUS contract; and

WHEREAS, the Administrative Code places additional requirements on EUS contracts that are not expressly authorized by statute and the Township has nevertheless determined pursuant to N.J.A.C. 5:34–2.3(b) that the compliance with such requirements is both impracticable as authorized therein for the reasons set forth in the Certification; and

WHEREAS, the Township, through its QPA has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for this contract as an appropriation created by Reserve for Beach Replenishment, Account # C-04-55-320-001 in the amount not to exceed of \$44,957.40

WHEREAS, the Township, through its QPA has issued the mandatory documents (packet) including but not limited to a Business Entity Disclosure Certification, pursuant to the provisions of N.J.S.A. 19:44A-20.1, *et seq.*, to CRC with the completed packet received and opened on March 4, 2021; and

WHEREAS, CRC has certified that it has not made any reportable contributions to a political candidate in the Township in the previous year, and that the contract will prohibit CRC from making any reportable contributions to a political or candidate committee in the Township through the term of the contract; and

WHEREAS, pursuant to the governing provisions of N.J.S.A. 40A:11-1, *et seq.*, and N.J.S.A. 19:44A-20.5, the Township has engaged in a legally authorized procurement process; and

WHEREAS, therefore, the Township previously concluded and again concludes that the CRC is the necessary entity to perform the required extraordinary unspecifiable service of shoreline monitoring, related scientific study and reports, and to ensure compliance with the conditions of the Army permit; and

WHEREAS, pursuant to and in accordance with the Local Public Contracts Law and based upon the opinion of the Township's counsel, the CRC is awarded a contract pursuant to the EUS and professional services exceptions to the local government bidding requirements.

NOW, THEREFORE BE IT RESOLVED by the governing body of Township of Long Beach, County of Ocean, State of New Jersey, in accordance with the foregoing Recitals, which are incorporated herein by reference, as follows.

- 1. That the Township does hereby award CRC, the contract proposal as Exhibit A pursuant to the EUS contract exception to the Local Public Contracts Law.
