APPOINTMENT OF MUNICIPAL TAX ASSESSOR

WHEREAS, N.J.S.A. 40A:9-146 requires every Municipality to provide for the appointment of a Tax Assessor; and

WHEREAS, the current tenured Tax Assessor has retired from their position leaving an unexpired term; and

WHEREAS, it is the desire of the Board of Commissioners of the Township of Long Beach to appoint Barbara Bielawne to fill the partial term of office starting on May 1, 2022 and an initial four-year appointment pursuant to N.J.S.A. 40A:9-146 beginning July 1, 2022 and ending on June 30, 2026, for an annual salary of \$82,000.00; and

WHEREAS, the assessor will hold public office hours on Monday through Friday from 9:00 a.m. To 4:00 p.m.

NOW THEREFORE BE IT FURTHER RESOLVED, Resolution 22-0513.02 was duly adopted by the Board of Commissioners at a public meeting held on May 13, 2022 to appoint a full time Tax Assessor; and
