RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO THE STOCKTON UNIVESITY COASTAL RESEARCH CENTER FOR THE NATIONAL FISH AND WILDLIFE GRANT-RESTORING BAY ISLANDS FOR COMMUNITY RESILLANCE PURSUANT TO THE EUS EXCEPTION OF THE LOCAL PUBLIC CONTRACTS LAW

WHEREAS, pursuant to N.J.S.A. 40A:11-5, a municipality is authorized to award a contract which exceeds the bid threshold without public advertising for bids pursuant to the extraordinary unspecifiable service ("EUS") exception; and

WHEREAS, the Township of Long Beach ("Township") and The Stockton University Coastal Research Center ("CRC") are entering into a contract in 2022 for the Restoring Bay Island Community Resilience pursuant to the EUS exception to the Local Public Contracts Law; and

WHEREAS, the Township's need services provided by CRC to reduce flood impacts to LBT communities by enhancing bay islands using natural and nature-based techniques that promote ecological health and wave; and

WHEREAS, as set forth in the CRC's proposal, which is attached hereto as Exhibit A and incorporated herein, the services include: (i) collaboratively working with the Monmouth University UCI to establish site assessment protocol at five islands within Barnegat Bay/Little Egg Harbor; (ii) collect appropriate wave, topographic/bathymetric and water level data; (iii) data analysis and sharing for preliminary design; (iv) reporting/meetings; and

WHEREAS, as a municipality located on an eighteen-mile-long barrier island, there are few issues, if any, more significant to the public health, welfare, and safety than the maintenance of the shoreline and the scientific study and reports relating to and in support of protection of the public from flooding; and

WHEREAS, based upon the services required and the expertise, reputation, its familiarity with the geographic location, and its proximity to the Township, the Township has concluded, based upon the advice of the Township's counsel and pursuant to the Certification of the Qualified Purchasing Agent ("QPA") that the services provided by CRC are specialized and qualitative in nature requiring expertise, extensive training and proven reputation in the field of endeavor, and, therefore, the contract complies with the EUS exception to the Local Public Contracts Law; and

WHEREAS, the designated administrative official of the Township duly prepared and filed a Certification with the Mayor and Commissioners describing in detail why the contract meets the legal requirements for an EUS contract; and

WHEREAS, the Administrative Code places additional requirements on EUS contracts that are not expressly authorized by statute and the Township has nevertheless determined pursuant to N.J.A.C. 5:34–2.3(b) that the compliance with such requirements is both impracticable as authorized therein for the reasons set forth in the Certification; and

WHEREAS, the Township, through its QPA has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for this contract as an appropriation created by NFW- Restore Bay Islands Account # G-02-40-935-001 in the amount not to exceed of \$35,499.55

WHEREAS, the Township, through its QPA has issued the mandatory documents (packet) including but not limited to a Business Entity Disclosure Certification, pursuant to the provisions of N.J.S.A. 19:44A-20.1, *et seq.*, to CRC with the completed packet received and opened on September 27, 2022; and

WHEREAS, CRC has certified that it has not made any reportable contributions to a political candidate in the Township in the previous year, and that the contract will prohibit CRC from making any reportable contributions to a political or candidate committee in the Township through the term of the contract; and

WHEREAS, pursuant to the governing provisions of N.J.S.A. 40A:11-1, *et seq.*, and N.J.S.A. 19:44A-20.5, the Township has engaged in a legally authorized procurement process; and

WHEREAS, therefore, the Township previously concluded and again concludes that the CRC is the necessary entity to perform the required extraordinary unspecifiable service of National Coastal Resilience Fund 2021, Restoring Bay Islands for Community Resiliency-Long Beach Township; and

WHEREAS, pursuant to and in accordance with the Local Public Contracts Law and based upon the opinion of the Township's counsel, the CRC is awarded a contract pursuant to the EUS and professional services exceptions to the local government bidding requirements.

NOW, THEREFORE BE IT RESOLVED by the governing body of Township of Long Beach, County of Ocean, State of New Jersey, in accordance with the foregoing Recitals, which are incorporated herein by reference, as follows.

- 1. That the Township does hereby award CRC, the contract proposal as Exhibit A pursuant to the EUS contract exception to the Local Public Contracts Law.
- 2. The Mayor and Municipal Clerk are hereby authorized to execute the contract, subject to the terms of this Resolution.
- 3. Pursuant to N.J.S.A. 40A:11-15, the contract may be extended for two one-year extensions at the same or less consideration set forth in the contract awarded herein.

RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO THE MONMOUTH UNIVESITY URBAN COACT INSTITUTE FOR THE NATIONAL FISH AND WILDLIFE GRANT-RESTORING BAY ISLANDS FOR COMMUNITY RESILLANCE PURSUANT TO THE EUS EXCEPTION OF THE LOCAL PUBLIC CONTRACTS LAW

WHEREAS, pursuant to N.J.S.A. 40A:11-5, a municipality is authorized to award a contract which exceeds the bid threshold without public advertising for bids pursuant to the extraordinary unspecifiable service ("EUS") exception; and

WHEREAS, the Township of Long Beach ("Township") and The Monmouth University Urbn Coast Institute ("UCI") are entering into a contract in 2022 for the Restoring Bay Island Community Resilience pursuant to the EUS exception to the Local Public Contracts Law; and

WHEREAS, the Township's need services provided by UCI to restoring bay islands by conducting project site assessments and preliminary restoration design for five bay islands for the dual purpose of ecological "health" and community resilience. The objective of the project is to reduce flood impacts to the community while providing ecological "uplift" to the marsh islands that protect the township and its neighbors from flood and wave impact; and

WHEREAS, as set forth in the UCI's proposal, which is attached hereto as Exhibit A and incorporated herein, the services include: (i) collaboratively working with the Stockton University Coastal Research Center (CRC) to establish site assessment protocols and data needs; (ii) collect appropriate wave, topographic/bathymetric and water level data; (iii) Combining site assessment data with available historic wind and water level data to develop; (iv) applying the 50% likely sea level rise rate to the project future design conditions in 2030 and 2050; (v) developing preliminary (30%) restoration designs for each island and estimate the surge and wave attenuation characteristics of each design; and (vi) working with NJBII and LBT professionals to develop cost estimates for each of the preliminary designs and prepare the concept drawings for pre-application permit review; and

WHEREAS, as a municipality located on an eighteen-mile-long barrier island, there are few issues, if any, more significant to the public health, welfare, and safety than the maintenance of the shoreline and the scientific study and reports relating to and in support of protection of the public from flooding; and

WHEREAS, based upon the services required and the expertise, reputation, its familiarity with the geographic location, and its proximity to the Township, the Township has concluded, based upon the advice of the Township's counsel and pursuant to the Certification of the Qualified Purchasing Agent ("QPA") that the services provided by CRC are specialized and qualitative in nature requiring expertise, extensive training and proven reputation in the field of endeavor, and, therefore, the contract complies with the EUS exception to the Local Public Contracts Law; and

WHEREAS, the designated administrative official of the Township duly prepared and filed a Certification with the Mayor and Commissioners describing in detail why the contract meets the legal requirements for an EUS contract; and

Rand Pearsall, Holgate-had concerns about dune grass taking on the bayside and also about the plans for the water treatment plant.

Mayor Mancini stated there is no update as the Twp. Engineer is out on medical leave. John Fiore, Brant Beach-wanted to know if the town could release which areas need most attention for the town-side cleanup so the Brant Beach Taxpayer Association can concentrate there and had comments regarding the street posts in the dunes have gotten positive feedback, but that they should be replaced.
