ORDINANCE 24-29C

**AN ORDINANCE OF THE TOWNSHIP OF LONG BEACH, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING CHAPTER 37, WHICH PERTAINS TO ALARM SYSTEMS**

STATEMENT OF PURPOSE

The purpose of this ordinance is to amend the false alarm regulations and violations and penalties in Chapter 37.

SECTION I

§37-3E is repealed and replaced with the following.

- E. After one false alarm warning, at the same property within any calendar year, the Township Alarm Administrator shall charge the owner and/or lessee of the property such penalties and fees as outlined in this chapter.

SECTION II

§37-4A is repealed and replaced with the following.

§37-4 Violations and penalties.

- A. A violation of this chapter shall be punishable as provided in Chapter 1, General Provisions, Article III, General Penalty, except that the following minimum penalties shall be applicable as a result of each false alarm, after initial warning was issued, each of which shall be regarded as a separate and independent violation.
  - (1) First false alarm: \$350.
  - (2) Second false alarm: \$500.
  - (3) Third false alarm: \$750.
  - (4) Fourth and each additional false alarm: \$1,000.

SECTION III

All Ordinances or parts of Ordinance inconsistent herewith are repealed to the extent of such inconsistency.

SECTION IV

If any word, phrase, clause, section, or provision of this Ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional such word, phrase, clause, section or provision shall be severable from the balance of the Ordinance and the remainder of the Ordinance shall remain in full force and effect.

SECTION V

This Ordinance shall take effect upon publication thereof after final passage according to law.

**Effective date.**

This ordinance shall take effect after final adoption and publication as required by law.
