ORDINANCE 25-21C

AN ORDINANCE AMENDING CHAPTER 180 OF THE TOWNSHIP OF LONG BEACH CODE, WHICH PERTAINS TO SWIMMING POOLS AND HOT TUBS

STATEMENT OF PURPOSE

This Ordinance amends Chapter 180 to prohibit any dewatering hose crossings from certain locations during times of year when there is an increase of pedestrian and vehicular traffic on the roadways during June 15 and September 15 of any calendar year.

SECTION I

§180-3D (3) (a) is repealed and replaced with the following.

- (a) Hose crossings over Ocean Blvd., Beach Ave, and Atlantic Ave. between June 15th and September 15th of any calendar year is prohibited. After September 15th all hose crossings at the above locations shall be approved by the Long Beach Township Police Department.

SECTION II

All ordinances, or parts of ordinances, inconsistent with this ordinance are hereby repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.

Effective date.

This ordinance shall take effect after final adoption and publication as required by law.
